Alternative Funding of Academic Libraries in Nigeria: Case Studies of Hezekiah Oluwasanmi Library, Obafemi Awolowo University, Ile Ife and Wusto Library, Wesley University of Science and Technology, Ondo

The author examines the present sources of income in the two academic libraries and comes up with a suggestion that alternative sources of funds are necessary for the survival of academic libraries in the 21st century. The researcher makes use of interview and documentary evidence for the study. The results of the study reveal that there other sources of income that have been neglected and which could have fetched the libraries a lot of money to keep them afloat. Such areas include, binding of Theses, reference services, printing, indexing and abstracting, consultancy services, e-resources, internet search, grants and aids. The study concludes that the management of both institutions should have a written policy on these alternative sources in order to give legal backing to the two libraries in order to effectively embark on the exercise to avoid crises and lack of understanding on the part of the users.

INTRODUCTION

An academic library is central and important in any academic institution. It's importance hinges on the relevance that is attached to research which is the core area in any university in the world. Research, being a continuum, is an exercise that must not be inhibited by any factor be it finance or lack of relevant books in order to achieve optimal results.

Library is in the front burner because any serious researcher must be in constant touch with the library for its needs. This is why the National Universities Commission {NUC} embarks on routine visitation to universities to ascertain the library holdings and their relevance to the academic needs of researchers and by extension lecturers and students. However, funding has become an albatross {Ola,C.O. 2001} because human needs are endless while the available resources are

This situation has drastically affected most limited. institutions to procure relevant books and materials coupled with their inability to sponsor staff to conferences and workshops. Therefore, there is a compelling need to source for alternative funds to meet the ever increasing demands of the library in order to be relevant not only to their clientele but the public. The fact that funds come from the university to the library has not really made librarians to be on their toes when it comes to fund raising either from corporate organizations or individuals and this situation has greatly affected the clientele over a long time Recently, the Librarian Registration Council {LRCN} organized a workshop in March 2013 at Enugu on grant proposal writing for librarians with the aim of equipping them to write beautiful proposals for grants

from donor agencies, yet, it should not be limited to this because there is the need to build the consciousness in librarians to always face the reality that funds are not forthcoming hence they have to seek for alternative funding to make ends meet.

The federal government who is the proprietor of federal universities is still battling with budgetary allocation to ministries and parastatals owing to instability in the world price of crude oil and oil theft. This situation has a great toll on the funding of universities and in recent times, universities have been receiving budgetary allocation as and when due which has drastically affected academic libraries. On the other hand, private universities are not finding it easy because funding of universities is capital intensive; there are lots of competing demands and their finances are contingent on student population. Most of the private universities had to increase their fees in order to remain afloat. This situation has great impact in the development of academic libraries hence it becomes imperative to source for alternative funding. Popoola {2005} opines that in view of the reduction in annual budgetary allocations to information service organizations especially libraries, archives information centres by their owners, the managers of these information systems must embark on priced based information services. This will enable them to recover their costs on the provisions of information services to users. He reiterated further that libraries must be capable of generating revenue if possible making maximum profit using appropriate pricing policy. He concluded that any good or service that is provided free is never valued.

History of Hezekiah Oluwasanmi Library

The history of Hezekiah Oluwasanmi Library dates back to the year 1962. It has a peculiar history in that it shares the same year of establishment with the parent institution- the Obafemi Awolowo University, formerly, university of Ife. It therefore has a long record of having provided information, academic and research support for the University for Almost 50years. It has continued to fulfill its main functions which are to acquire, process, organize for use, and preserve such recorded communications as could serve the teaching, research, cultural and service needs of the entire university.

The university library took off from the building of the Nigerian College of Arts and Technology, Ibadan, the temporary site of the then university of ife, before the initial collection was moved to ile ife in 1967. The movement came up at the same time the other existing faculties were moved to the permanent site. The library was named Hezekiah Oluwasanmi Library (H.O. Library) on 12th December, 1980 in a colorful ceremony in honour of the former Vice Chancellor, Professor Hezekiah Oluwasanmi.

The library now occupies an imposing gigantic two

wings, Southern and Northern wings, which are connected by two walkways. The Southern wing, a four (4) storey building, covers a total area of 42000sq ft., was designed to accommodate 250,000 volumes with sitting facilities for 800 readers. However, by 1980 due to rapid expansion in students' enrolment as a result of introduction for new academic programmes, the building capacity became inadequate. Thus, there was a need to plan an expansion, to cater for additional 500,000 volumes and to bring the seating capacity to accommodate about two thousand and five hundred (2,500) users. The Northern wing was completed in August 1983.

History of Wusto Library

The Library commenced operations on 11th July, 2008 when Revd. B.F.Akindojutimi on sabbatical leave from the Obafemi Awolowo University, ile ife, resumed duties as Acting University Librarian. On his arrival, Mrs Joke Yankey, one of the two Confidential Secretaries was posted to the Librarian. Some books, about two hundred and on various subjects, donated to the University formed the foundation of the Library's collection. No other thing in terms of tools and equipment was available. As time progressed, office essentials and working tools were acquired.

The library benefited immensely for the Adeyemi College of Education, Ondo Libray where cataloguing was initially done and Hezekiah Oluwasanmi Library, Obafemi Awolowo University, ile ife that donated a set of library of congress classification scheme to WUSTO library through the efforts of the Acting University Librarian.

The collection has been growing steadily in all disciplines. Currently, there are a total 2980 volumes of books, 135 journal titles, 48 rich and current reference The Library subscribes to two national dailies; Nigerian Tribune and The Punch and one weekly Magazine, Tell. The Library also serves as repository for other newspapers that were subscribed to by other units of the university. There are 60 functional computers in the e-library, while six others serve the TEEAL Library. In April, 2010, the library received a donation of The Essential Agricultural Library (TEEAL) from Albert R. Mann Library, Connel University, USA. This equipment which is worth S1, 000 contains 140 science journals and 19 monographs, updated to 2011/2012. All the PCs in the e-library are from the three hundred computer units ordered and paid for through Computer Aids International in the United Kingdom by the University. expenditure was sponsored by Arc. Ete, a devout Methodist and the Lay President's Council under the influence of Sir, Bola Ogunsanwo, the Secretary of WUSTO Board of Trustees. The computer units were shipped from UK on September 12, 2011 and delivered in

WUSTO on Thursday December 8th, 2011. Plans are underway to upgrade facilities in the e-library to meet international standards.

Statement of Problem

Funding of academic libraries has always been a recurring decimal. The inflationary trend in the country is quite alarming and this has a great toll on the operations of the library especially academic libraries that have in one of its objectives the provision of research. Funding challenges has manifested in the inability of libraries to procure essential materials and sponsor staff on training. This study seeks to find out the current budget and sources of funds for the two libraries and factors that may affect the introduction of new sources of funds as viable alternatives for income generation.

OBJECTIVES OF THE STUDY

The study aims at examining the existing sources of funds for academic libraries and proposes viable alternatives for income generation to assist the libraries to function properly.

RESEARCH QUESTIONS

The following research questions are tenable:

- 1. Is there any budget for academic libraries?
- 2. Do you receive your budget as and when due?
- 3. What are the current sources of revenue for your library?
 - 4. How much do you charge users?
- 5. Are you satisfied with the income generated so far?
- 6. If no, what are the other sources of revenue for the library?

METHODOLOGY

In order to obtain up to date information for this research, documentary method and interview were employed for the study. The researchers were able to check the documents in the various institutions as copious evidence and obtained valuable information from the staff on how they generate funds and how much that has been generated from such undertakings in the past three years.

The information got from the interview and documentary evidence was carefully tabulated in the past three years spanning 2010, 2011, and 2013 respectively. Other sources of funding as Alternative Avenue for income they would have generated in the past three

years were equally highlighted.

Literature Review

Funding can be defined as an act of providing resources, usually in form of money or other values such as effort or time for a project, a person, a business, or any other private or public institutions. Abubakar[2011] citing [Akporhonor,2005] defined academic libraries as libraries attached to tertiary institutions such as universities, polytechnics, colleges of education, college of agriculture, college of technology and also research institutes. Academic libraries are at the forefront of providing services to their respective communities which comprises students, lecturers, and researchers in order to support their teaching, learning and research needs. Scholars have emphasized on the crucial role of academic libraries in research and scholarship in institutions of higher learning.

Ubogu and Okiy [2011] remarked that funding models for academic libraries vary greatly, depending on whether the institution is private or public. The university fund administration can be categorized into three; recurrent, capital and research. It has been suggested that the aggregate cost per year to train a student in a medium range international level University across disciplines is US\$20,000.000(twenty thousand US dollars) which is about N2.5m today. Tertiary educational institutions should constantly explore ways and means of meeting its academic obligations and at the same time generate fund to improve their environments.

University libraries receive direct allocations from the parent institutions and being one of the various units in the university, it has to compete with other units based on the available funds from the host university [Ubogu and Okiy 2011 citing Omotayo, 1997). The fact that funds come from the university to the library has not really made librarians to be on their toes when it comes to fund raising either from corporate organizations or individuals and this situation has greatly affected the clientele over a long time Recently, the Librarian Registration Council {LRCN} organized a workshop in March 2013 at Enugu on grant proposal writing for librarians with the aim of equipping them to write beautiful proposals for grants from donor agencies, yet, it should not be limited to this because there is the need to build the consciousness in librarians to always face the reality that funds are not forthcoming hence they have to seek for alternative funding to meet ends need.

It has been observed by several scholars in the field of librarianship that the most critical challenge facing librarians as we enter the Third millennium is how to generate revenue that can replace the institutional support we once assumed would never stop. Academic libraries in most of the federal and state universities are facing budget reduction or cut. At the same time, some

university administrators still look to library as one of their challenges because of the cost of building collections. Some university administrators look to the library as a bottomless pit that can absorb all the funds available: they think no institution has enough money to maintain and operate a library that is satisfactory to the faculty. The Academic staff union of universities (ASUU) has proposed some solutions to this myriad problem as a way to tame the ugly monster headlong. Awuzie (2012) reveals that there are certain areas which ASUU members believe could be good sources of funds for the universities apart from the statutory allocation which has fallen short of the expectations of the government controlled universities. The sources of funding identified by the ASUU agreement include:

- Government
- (a) A minimum of 26% of the annual budget of the government be allocated to education
- (b) The federal ministry of education should pursue vigorously the issue of putting education in the first charge category,
- (c) Federal Government should provide general assistance to state governments for university

and higher education as allowed in section 164(10 of the Nigerian constitution.

- 2. Tertiary Education Trust fund (TETFUND)
- (a) Return ETF to its original concept as Higher Education fund,
 - (b) Make TETFund an intervention fund,
- (c) Transfer of landed properties to universities,
 - (d) Patronage of university services,
 - (e) Funds from Alumni Associations,
 - (f) Private sector contributions.

Abubakar{2011} remarks that the situation in private universities also tends to portray a gloomy picture as the story seems to be the same. In most private universities, the proprietor dictates the tune and when money is not forthcoming the library is worst hit because there would not be priority for procurement of books and materials and the only song in such situation is survival.

Most libraries are experiencing funding problems because Nigeria as a country is facing economic quagmire. According to Nwafor{2013} the third world university libraries are currently perched on a precipice. The state of emergency could be declared in the libraries

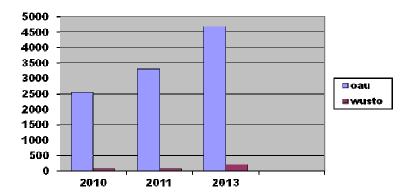


Table 5 Total number of Graduates in the last three years

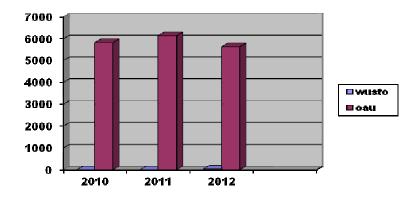


Table 6 Total Amount made from the present revenue sources

as a result of the worrisome state of our publishing industries coupled with the shortage of paper, ink, photographic plates, and printing machines. This situation has led to few publications in our countries and the frustration of librarians is shared by the reading public.

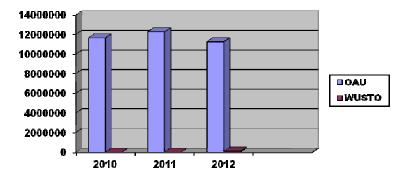
Ubogu and Okiy{2011} advised that library should be accorded high priority because it permeates every strata of the society just like water and air, libraries have an integral part of human existence. Fund is needed to meet all these competing demands if it has to be relevant in the society.

Okon {2013} said that school without a library is not a school. Therefore, it is important to fund the library

without any hesitation and being a growing organism, it has to be continually funded in order to meet the global challenges. Books are to be constantly procured and processed by competent Librarians who must of necessity be well remunerated. Ola, C.O.{2011} opined that to starve university of funds is a dangerous exercise that will eventually stifle or paralyze research exploits and academic engagements. He expatiated further that the importance of the library can be measured from the rating given it during accreditation exercise by the National University Commission{NUC} and other professional councils of various disciplines. The quantity and quality of research outputs in any institutions can be easily

measured by the type of library that exists in such institution.

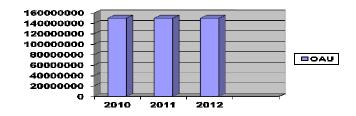
The table indicates that although there is a budget for both libraries but the full implementation of the budget is contingent on fund availability. Therefore both institutions don't receive the budget as and when due.

In table 2 above, four sources of revenue generation were identified and both libraries have been using these sources for a long time to augment allocation from their parent institutions.

In table 3, it has been observed that the four sources of income for both libraries can not meet the expectations of both libraries because only few incomes come through those sources. It is therefore imperative to seek for alternative sources for both libraries to survive.

The Need for Alternative Funding

In basic economics, it has been stated that man has

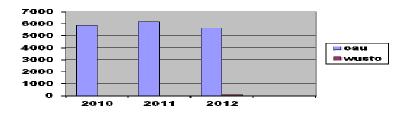

insatiable wants and resources are scarce. Therefore, we need to source for other sources to complement the limited resources. The second reason hinges on the fact that library has to prove to the academic community that it can stand on its own and cater for its needs. It is only when the library is able to generate its own revenue that it can have the boldness to challenge any unwholesome entreaties against its revenue. The library being a growing organism is constantly in need of money to finance its multifarious projects in the ever changing technological age. The resources to cater for the library in this digital age is enormous hence, alternative sources of funds are compelling factors for the sustenance of the library. The library must constantly be furnished with current books to meet the ever increasing research demands of its clientele because lack of necessary materials are negative factors and flaws during the accreditation exercise which might not be ascribed to the university management immediately but to the University Librarian who is believed to be a professional that is saddled with such responsibility. For instance, if any faculty fails the accreditation exercise, the University librarian shares in most of the blames likewise when

faculties are fully accredited, he receives the accolades. Essentially, alternative sources of funds must be on the top priority of any academic library not only for the institution but also for the relevance of the library profession.

The figures above show the level of registration in both libraries and the total for the last three years.

The table indicates the total number of graduates in both institutions during the period under review.

Both institutions stand to garner a lot of money from bindery .Total amount accruable to the Obafemi Awolowo University, ile ife runs into millions of naira yet it remains untapped despite the cash crunch bedeviling the university. WUSTO stands to rake in reasonable amount to augment the meager resources at the disposal of the Library. This source can be worked upon and it is quite feasible.

It is quite evident that a lot of money could be generated from other sources such as customary court court records that were kept in the custody of the Obafemi Awolowo University, Ile ife. People from all works of life do come for consultation of these important documents that comprise all customary court

proceedings of the Western Region of Nigeria from 1900-1960.

The table above indicates the list of alternative sources of funds for both institutions. These alternative sources are yet to be explored but they are viable alternatives to assist the library to keep afloat.

From table 7 above, it is guite revealing that OAU, ile-Ife could have generated a sum of N24, 138,600 from binding of theses alone. This amount could have been utilized on other areas that could have advanced the course of the library. In addition to this, the bindery section of OAU has enough personnel and equipment that could have been put into optimal use during the period.

WUSTO on the other hand could have equally realized a sum of N86, 000 from binding of theses. This is a reasonable amount which can increase within a short time.

The cloak room is a place where bags and personal belongings of the users can be kept while in the library. It must be noted that books are only allowed into the library and it becomes necessary for the users to keep their belongings in a safe place whenever they are in the library. The sum of N5 can be charged for such service and it can boost the revenue base of the library within a short time. It has been observed that at least 10% of the total number of users have something to keep in the library in a day and this can be translated into money if such service is being monetized.

Library consultancy is another money spinning venture which any library with requisite personnel like the Hezekiah Oluwasanmi Library, could embark upon. It is quite obvious from the analysis that if the library consultancy is well utilized it can provide a respite in the time of financial crisis.

From this table, it has been discovered that other sources for income generation for both institutions such as grants, increase in registration fees and fines and charging of fees for the use of carrel could as well assist both institutions to remain afloat. These areas are to be considered by the management of both institutions.

DISCUSSIONS

From the study, it has been discovered that alternative sources of money for both libraries are many. Income generation must not be limited to imposition of fines and registration of users. It was quite obvious that final year students in both institutions bind their projects outside despite presence of a standard bindery in Obafemi Awolowo university, ile ife although, WUSTO library, Ondo does not have a bindery yet efforts should be made to establish the section in the library in other to generate more revenue for the library. Other alternative sources that were untapped include, court records, reference services, consultancy services, use of carrels.

Grants/Aids, printing, indexing and abstracting and use of e-resources and internet search.

CONCLUSION AND RECOMMENDATIONS

The results of this study have indicated that academic libraries in Nigeria must of necessity find alternative funds for their survival and this action must be vigorously pursued as a matter of duty because governments at all levels are gradually disengaging in the funding of social services in the country. This is equally peculiar to private universities whose survival squarely rests on income generation because they are private establishments. In view of this, management of the Obafemi Awolowo University, ile ife, and Wesley University of science and technology, Ondo must have a written policy on how to generate money in their libraries. This becomes imperative because students have to be properly brief in order to avoid crises in the ivory tower which may be volatile. The second reason has to do with the need to provide a legal backing for the library management in the discharge of their duty.

Then management of both institutions must properly sensitize their staff on the importance of this exercise such that seriousness will be attached to it and there will be accountability.

The management must be ready to give certain percentage of the income generated to the staff at the end of the year as a way of encouragement.

The study revealed that there must be training and retraining of staff especially in the area of grants proposal writing and financial management and business administration. These courses will effectively empower them to perform optimally and transform the library within a very short time.
